A question from the floor asked about the possible renewal of the lease from 2017 when the current leaseholder, The Environment Agency, has indicated that they will not be continuing. Rick advised that there are talks in progress with other agencies and the committee is very hopeful that we will be adopted prior to the end of the lease. Further details cannot be revealed at present as talks are still at an early stage.

## **Comments**

#### Income

Regular

Standing orders /memberships: £350 this year. We are very grateful to those people who have paid regularly.

Donations: £1322.30 this year. Again we are grateful for these as we could not manage without them. We have had a small increase in donations this year.

Other donations: Nurture Lakeland. This organisation has kindly given us £1214.48 this year, which has allowed us to improve the seating on the reserve by purchasing a picnic table which can accommodate wheelchair users, install new display frames and also look to improving the signage.

At present the regular standing orders/ memberships and donations are more than covering our running costs and allow us to look at funding improvements to the site.

## **Costs**

## Bird feeding: our single major cost.

Last year's mild winter meant we spent less than estimated on bird food. However we still need to monitor this carefully and I estimate that we need to allow for in the region of £550 p.a. for bird feeding next year. This depends on the weather!

### Insurance

We have used £1407.44 of the £2870 given to us by Bassenthwaite Reflections. We have £1462.56 left. This is ring fenced and only to be spent on insurance. Unless there is a large increase in insurance costs this should be sufficient until 2017.

## Equipment / maintenance

Costs are slowly increasing as the site ages. Some of this year's costs have been repairing damage caused by flooding, inevitable given the nature of the site. Further costs are unknown... £100-150 pa? We have had little costs so far as most of the equipment is new and only minor costs have been incurred.

### Website

Last year we paid £14.16 to register the name of our web site for 3 years. This has 2 more years to go before reregistration. We are now paying for hosting the site, so far this is costing £60 per year.

### **Improvements**

We have spent £557.09 on printing 10 000 new leaflets for the reserve, as the original ones have run out. We are looking to improving the signage which will be a major cost with £250 spent so far. The exact amount of signs will depend on our budget at the time.
